



Updated: 24<sup>th</sup> September 2020 - **WAKEBOARDING**

ALL bookings for wakeboarding must be made online, where possible, through our website prior to using the facility but alternative payments methods are available.

Each customer will be limited to their allocated session and will be required to leave the site soon after the sessions ends.

Each customer must be able to change outdoors or at your car as changing areas will be unavailable. Toilets will be available for use.

A distance of at least 2 metres must always be kept from other customers and staff. Please use the markings on the floor when waiting.

Each rider must be able to competently start from the bench as grass starts will not be allowed. Beginners will be instructed on how to do so.

Rental equipment will be available for those that require it. Please use own equipment where possible.

Spectating is limited to the household of a person participating. Please keep your distance from other spectators, riders, and staff on site.

Please note that Aqua Park sessions are no longer limited to the same household and other members of the public could be sharing the equipment. Festwake have reduced the maximum number of people on a session to help observe social distancing.

Please arrive ready to use the Aqua Park. Changing rooms will not be available on site so please make sure that everyone has swimwear on. Life Jackets (Included) and Socks (£2) will be provided, with the option of a wetsuit. Toilets are available on site.

You may wish to wear a face mask when arriving to the site, however anyone participating will not be permitted to wear anything covering the face whilst on the Aqua Park.
